2. The applicant shall have the following qualifications: i) Executed similar nature of civil works (New or renovative) in any Government departments, public sector undertaking. Local bodies or any reputed organization and completed the work (ii) annual turnover of Rs. 40 Lakhs for the last The bidder is to submit a refundable security (E.M.D) of Rs. 50,000/- (Rupees Fifty Thousand only) in the shape of demand draft separately on any nationalized / large private bank (Viz. ICICI Bank. HDFC bank and Axis Bank) in favor of CROSS BORDER POWER TRANSMISSION COMPANY LIMITED, payable at New Delhi along with bid documents in separate envelop. Bid submitted without EMD will be rejected outrightly. MSME registered vendor having relevant industry classification for the subject works shall be exempted from submission of EMD as per rules subject to submission of documentary evidence in a separate envelop
