

- CPTC Constructed 400 KV D/C Muzaffarpur-Sursand Transmission line and initially charged at 220 KV level. Subsequently the transmission system was charged at 400kv voltage level and 2no 220 KV line bays along with few towers becomes spare at POWERGRID Sub-station for alternative use.
- 2. BSPTCL needed the aforesaid spare 2 No line bays and one no tower near Gantry to terminate its, 200 kV Muzaffarpur-Chhapra (New), Amnour transmission line at POWERGRID Muzaffarpur Substation.

3. CPTC board of Directors and BSPTCL board of Directors, approved the transfer of the subject assets at book cost plus GST on the date of transfer after all necessary regulatory and statutory clearances.

- 4. Keeping in view the urgency of charging 220 kV Muzaffarpur- Chhapra (New), Amnour transmission line at Muzaffarpur S/S, BSPTCL has requested for permitting use of 2 no. 220 kV AIS bays &1 no. 400 kV DD tower near gantry at 400/220 kV Muzaffarpur (POWERGRIG) Substation of CPTC, till actual sale/transfer proceedings are completed.
- 5. CPTC agrees to allow use of the above referred assets by BSPTCL on the following terms & conditions:
- i) BSPTCL has to deposit entire estimated book value of the assets plus applicable GST amount as on 31.1.2023 amounted to Rs. 8,28,07,689.00 in advance as a security deposit till actual sale/transfer of assets.
- ii) Actual sale/ transfer of the subject assets shall take place only after getting Regulatory approval from CERC, to do so under relevant Electricity Act.
- Permission for use is being allowed in anticipation of necessary regulatory approval, which is under process. In case the same is not granted by CERC for any reason, CPTC shall refund the entire amount so deposited by BSPTCL without interest or any other liability.
- iv) Only after receipt of regulatory approval from CERC, formal sale-purchase agreement between CPTC and BSPTCL shall be signed.
- v) Permission-to-use of the assets initially, and later on sale/transfer shall be purely "as is where is" basis. Any alteration or modification in the assets if required for bring in to operation is entirely the responsibility of BSPTCL. Further during use of assets and after taking over the subject assets on sale /transfer, BSPTCL shall be responsible for its Operation & Maintenance at own cost, including all incidental expenses.
- vi) It is the responsibility of BSPTCL to take any permission/ approval from any authority/institute including POWERGRID before use of the assets where ever it is required at their risk and cost.
